3. Reports

3.1 Police report.

PCSO Whitehead sent out the report. The Clerk had previously sent it out to the Parish Councillors.

3.2 County Councillor Les

Following on from concerns from a resident earlier in the year about whether emergency vehicles such as fire engines would be able to cross the stone bridge by the Oak Tree if the Beckside road was blocked, Cllr Less has been in touch with the fire service. They have since sent a fire engine to test if this would be possible. They can get the appliance across the bridge but they would use Beckside in preference as it is a quicker route.

An informal implementation board has been set up to discuss the formation of the unitary council. This consists of representatives from the 7 District Councils and members of the County Council. There will be 89 wards with 90 Councillors. Catterick Village will remain in the Catterick Bridge Ward and will have one member.

3.3 District Councillor Rowe.

RDC are providing subsidies for 4 electric taxis in the District.

The implementation of Community car charging points has been delayed.

£1.4 million is to be spent on the Richmond Swimming pool.

3.4 District Councillor Threlfall

There has been a 40% increase in planning applications since Covid.

Catterick Cricket Club has been awarded a grant from the Central Area Partnership for a grass cutter.

RDC have been given a government grant to pilot a scheme for installing recycling bins in the area. One has been installed on the footpath outside the health centre.

3.5 Marne Barracks.

They are expecting to be told the outcome of the defence review in November. 3 personnel have been sent for training to drive commercial tankers.

4. Minutes

The minutes of the meeting held on 6th September 2021 were approved

5. Matters arising.

6. Current Issues.

6.1 King's Park Play Area upgrade.

It was decided to leave the mound in the Play Park because of the costs involved in removing it. The Clerk has contacted Streetscape to see what equipment could be

integrated into this. They suggested a toddler slide. The clerk sent the details to the Parish Councillors by email and it was agreed to do this. The Clerk has since contacted the firm to place the order for the upgrade. Hopefully this will be in November.

6.2 Poppy Wreathes,

The Clerk asked if the Parish Councillors want her to order 2 wreathes, giving a £100 donation as usual, for Remembrance Sunday. No one has heard if a parade and service are going ahead this year but the Councillors agreed that they would still want 2 wreathes for the memorial.

6.3 Litter Bins and dog bins.

In July Cllr Threlfall brought a motion to the full district council that would allow Parish Councils to purchase additional bins from their own funds and these would then be installed, emptied and maintained by District. This was supported by the District Council. Earlier in the year the Parish Council had wanted to purchase 2 bins and install one in each of the laybys by the racecourse but District then said that they would not be emptied on a regular basis.

The Clerk asked the Councillors if they would now like to go ahead with the purchase of these bins - either £250 /bin for a normal litter bin or £700 for a recycling bin. The Councillors agreed to 2 normal litter bins. The Clerk will contact RDC.

Cllr Threlfall has mentioned the need to replace the dog bin in the field by Chapman's Court. The Councillors agreed to this and to having it moved nearer the gate. Cllr Threlfall will organise this.

7. The periodic accounts

These were circulated prior to the meeting and were approved and accepted by the members.

8. Correspondence.

- **a)** The Clerk has received a letter from the Great North Air Ambulance asking for a donation. The Parish Councillors agreed it was a very good cause and agreed to give £250.
- b) The Clerk has received a letter from Citizens Advise asking for a donation. Over the last year they have helped 74 families from the village with problems such as benefits and tax credits, universal credit, debt and unemployment. Again, the Councillors wanted to give support and agreed to £200.

9. Planning Applications.

10. Minor Matters.

Cllr Rafferty has asked our tree surgeon to look at the trees in front of the houses by the bus stop. As it is in a conservation area any major work will need permission from RDC.

Cllr Young said that he hopes to do a 'Christmas Lights Switch On' again this year. He has already asked the co-op if they will donate sweets and mince pies etc as

previously. He also said that Colin Browne has offered to donate a Christmas tree this year.

Cllr Claypole sent an email to the clerk saying that 2 people have asked her about the locked gate on the footpath from East Appleton to the link road near Leases Lane – and querying whether it was a through route. The Council thought it was. Cllr Wyrill said that there is a notice with a contact number on so that the code for the padlock could be obtained. Cllr Les said that the Rights of Way Officer could be contacted if there is a problem.
