Minutes of the Parish Council Meeting Monday 4<sup>th</sup> March 2024 Present: Cllr Campbell, Cllr Young, Cllr Ryan, Cllr Wyrill, Cllr Bhatti and Cllr Les

## 1. Apologises for absence.

Cllr Claypole and PCSO Smith.

## 2. Open forum.

8-10 residents attended the meeting with concerns about the planning application 20/00090/AORM Re-Consultation for Application Reference 16/00315/OUT 9 new dwellings at land North West of Manor House Low Green Catterick Village.

The Clerk has received 3 requests to speak at the meeting. All had similar concerns about the development, one of the main ones being the access to the site and the increase in traffic. They said the entrance is on a blind corner, already with a residential access and out onto a narrow road with no pavement. One resident said that when the application was first applied for she measured the width of the road from Pallett Hill down past High Green to Chapmans Court and onto High Green and for the majority of this length the width was between 3.45-3.75m. At only 3 points did they measure 5m or more. She wondered why the road in the development was 5.5m with footpaths but they thought it was safe for the vehicles to go onto a much narrower road without footpaths.

Any increase in traffic would increase the likelihood of accidents occurring – especially as this route is regularly used by families, children and wheel chair users. It was suggested that access to the site should be from the North end and have the entry by Chapman's Corner closed off apart from for the use of pedestrians and horse riders.

They also wondered why the width of the bridleway had been reduced from 3m to 2m over 75% of the length

Surface water run-off is now to be diverted into the pond behind the development, they were worried that this would affect the wildlife and ecosystems here.

The Parish Council also mentioned that the lack of detail about the sewage system was also a concern, especially as the development at Bishop's Way still has no adequate system. The developers mentioned that there is a Yorkshire Water manhole cover on the Low Green Road which they assume is adopted by Yorkshire water but no survey has been carried out on the pipes to confirm suitability.

The Parish Council agree with the points raised by the residents and the Clerk will send the objection of the Council to the Planning Department. They will also ask if a site visit can be arranged for the interested parties and ask that the decision is made at a Council Planning meeting rather than just by the Planning and Community Development Manager.

Cllr Les said that he would also ask for a site visit and a Council Planning meeting decision.

### 3.2 North Yorkshire Council

Cllr Les said that the budget deficit has been reduced from £35 to £1 million. This is due to the formation of the Unitary Council from 8 separate District Councils and the reduction in Councillors to just 90.

55% of the budget now goes on Social Services – both adult and children's.

Childrens school transport, especially for SEN children being a large part of this.

A petition with 750 signatures has been handed into the planning department objecting to the Motorway services.

#### 3.3. Marne Barracks

Maj, Dent attended the meeting. The contractors are still carrying out survey work ahead of any construction work at the Barracks.

The construction team have been in touch with Highways about opening up an entrance for construction traffic from the Local Access Road.

A water treatment plant is about to be installed to alleviate the problem caused by blocked pipes due to the hard water.
